PROCEEDINGS:-

In the Tamil Nadu Generation and Distribution Corporation Limited Proceedings read above, the name of Thiru T.Thirunavukkarasu, Assistant Executive Engineer/ Electrical has been included in the panel (for the year 2012-2013) of Assistant Executive Engineers/Electrical suitable for promotion as Executive Engineers/Electrical.

2. Consequent on the above orders, under Regulation 92 of the Tamil Nadu Electricity Board Service Regulations, read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme, 2010, Thiru T.Thirunavukkarasu, Assistant Executive Engineer/Electrical/O&M/Palacode/Dharmapuri Electricity Distribution Circle, is deemed to have been promoted and appointed as Executive Engineer/Electrical, in Class-I (Division-III, Category-3) of the Tamil Nadu Generation and Distribution Corporation Limited service with effect from 18.09.2013 (Notionally) i.e. the date of joining of his junior Thiru M.R.Padmakumar, as Executive Engineer/ Electrical.

Thiru T.Thirunavukkarasu, Assistant Executive Engineer/Electrical/O&M/Palacode/Dharmapuri Electricity Distribution Circle, on promotion is posted as Executive Engineer/230KVSS/SIPCOT/Tuticorin/Tuticorin Electricity Distribution Circle in the existing vacancy, subject to the outcome of the M.P. He is eligible for fixation of pay in the post of Executive Engineer as per note-2 under regulation 37 of Tamil Nadu Electricity Board Regulations, read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010. As Thiru T.Thirunavukkarasu, Assistant Executive Engineer/Electrical had not actually acted as Executive Engineer, his pay shall notionally be fixed with effect from 18.09.2013 (i.e.) the date of joining of his junior Thiru M.R.Padmakumar, as Executive Engineer/Electrical.

The Superintending Engineer/Dharmapuri Electricity Distribution Circle, is requested to relieve the official under orders of promotion and posting immediately by making local arrangement without waiting for substitute and instruct him to join at the new post before expiry of joining time. A report should be sent to the Tamil Nadu Generation and Distribution Corporation Limited regarding the date of relief and date of joining of the official. This will be apart from the Certificate of Transfer of Charge.

The Superintending Engineer/Dharmapuri Electricity Distribution Circle, is also directed to ensure that whether, any disciplinary proceeding is pending/charges framed/punishment awarded, if any, against the official mentioned in para-2 above, before serving the promotion order. If so, necessary clarification may be obtained from the Secretary before serving the said promotion order to the official concerned.

Thiru T.Thirunavukkarasu, Assistant Executive Engineer/Electrical is requested to return the option format duly filled in, within one month from the date of promotion and assumption of charge. If the option format is not received within the said period of one month, his pay in the higher post will be fixed as specified in para-3 of Board's Memo. No.75406/P1/90-1, dated 19.3.1991.
