In the Board's Proceedings first and second cited, among other things, orders were issued for grant of an additional increment to the employees on movement to Selection Grade / Special Grade in the same Pay Band and Grade Pay over and above the existing one increment benefit.

2) The Chief Internal Audit Officer / Audit Branch has sought for clarification whether the grant of the above one additional increment be calculated on cumulative basis or non-cumulative basis.

3) It is hereby clarified that the additional increment should be calculated on non-cumulative basis only i.e., an officer drawing a pay of Rs.29340 + 6100 G.P. in the Pay band of Rs.15700-39100 + Rs.6100 G.P. should be calculated at 3% + 3% (Rs.1070+Rs.1070/-). The same procedure shall be followed to the future cases also.
