**PROCEEDINGS:**

In the Board's Proceedings first read above, orders were issued that at the time of retirement, 50% of Unearned Leave on Private Affairs standing at the credit of the employees upto a maximum of 90 days, be entitled for encashment and drawal of full leave salary subject to fulfillment of conditions specified therein. The Board, on a review of the above orders read with the clarificatory orders in the Memo second read above, in its meeting held on 28.8.1997, resolved that the same may be kept in abeyance with immediate effect. Accordingly, orders were issued in the Board's Proceedings third read above.

**2.** All the Trade Unions and the Pensioners Association of the Corporation have been requesting for the restoration of the aforesaid benefit to the retiring employees. The said requests have carefully been considered.

**3.** After considering the aforesaid aspects, the following orders are issued:-

- (i) The encashment of 50% of Unearned Leave on Private Affairs kept in abeyance in the Board's Proceedings third read above, is hereby restored;
- (ii) In view of the huge financial commitment in restoring the said benefit and as the TANGEDCO is also facing financial constraints, the arrears accruing consequent on approval of this proposal could not be paid in one lumpsum and the same shall be paid in instalments to the pensioners as requested by the Pensioners' Association. The arrears accruing on restoration of the benefit of encashment of Unearned Leave on Private Affairs to employees/officers, retired/died up to 31.1.2014, be paid in ten equal monthly instalments;
- (iii) The first installment will commence from April, 2014.
