**Sir,**

**Sub:** Promotion to the post of JE Grade I/Mechanical – Issued for 28 Nos, of engineers – Cut-off date fixed for passing the ED test – Thiru.P,Mathavan, JE Grade II/TTPS and others – Missing the date by a very small space and not included in the approved panel – Relaxation of cut-off date and granting of promotion - Orders – Requested - Regarding.

We would like to bring the following matter to the kind notice of the respected CMD and request urgent favourable action.

In the reference cited, promotion orders were issued to as many as 28 numbers of Junior Engineer Grade II/Mechanical promoting them as Junior Engineer Grade I/Mechanical.

In this connection it is relevant to mention here that even though the above said promotion panel was called for as early during May-2014, it was delayed for more than two years. This has resulted in filing of cases by our union and finally, the promotion orders were issued subsequent to court orders.

However, the time lapse of two and a half years had not been taken into consideration while effecting the promotion and the crucial date for passing the ED test originally fixed at the time of calling the panel was not altered. In the event of delay in preparation of the panel, the cut-off needed to be elongated. But, here the cut-off date was not re-fixed. And the date initially fixed (on or before 20.04.2010) was taken into account, resulting in exclusion of some of the deserving engineers. For instance, one Thiru.P,Mathavan, Junior Engineer Grade II/TTPS has passed the ED test during May-2010 and missed the cut-off date by a small space of time and not included in the panel. Few other persons who are similarly placed have also been left out. Having anxiously waited for the promotion for more

We therefore, urge the respected CMD to consider the above matter sympathetically and order the personnel management to relax the crucial date fixed for promotion to the post of Junior Engineer Grade I/Mechanical and extending the same by May-2010, as against the original date of 20.04.2010 and consequential promotion orders may kindly be issued to Thiru.P,Mathavan, Junior Engineer Grade II/TTPS and other similarly placed persons please and thus render them life and justice.
